TERMS & CONDITIONS

1. Responsibility

I declare that I am taking part in this practice intensive, offered by Lorella Ricci, of my own free will. I am aware that the workshop does not offer medical help in the classical sense. The workshop is designed to give you, the participant, a framework for your self-growth by your own recognisance. I agree to follow the rules and instructions of the workshop or Lorella's assistant, and I agree to take full responsibility for my actions during my attendance.

2. Health check, Medical costs, Medical confidentiality

I hereby declare that I am not suffering from any psychological, or physical illnesses that could put myself, other participants, or the instructor in any danger, or harms way. I consent to having a consultation talk with the instructor, if they deem it necessary and understand that the instructor relies on my honesty and accuracy of information that I have given in regards to my physical and mental condition, as well as, my medical and psychiatric case history.

I am obliged to immediately inform the instructor of any changes in my mental, or physical condition, which might in my best estimation bring into question my further participation in the workshop, or training. I am obliged to inform either the instructor of any medication I am currently taking, or take on a regular basis.

3. Release from Liability

I agree to release both the instructor and Lorella's assistant and all third parties claims of material or intangible form for this workshop.

4. Alcohol & Drugs

I understand that the use of alcohol and drugs, or any mood altering substances (hallucinogenic, tranquilizers, etc.), are strictly prohibited and not to be used during this workshop.

5. Confidentiality
